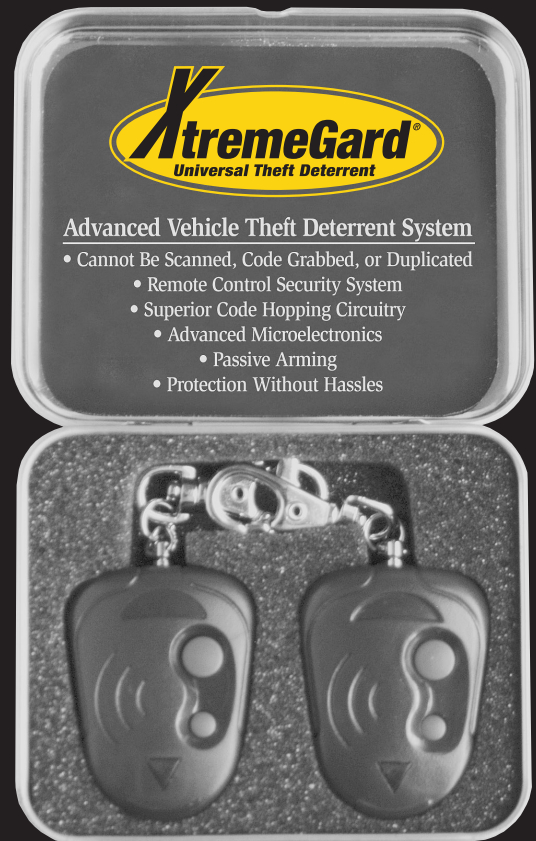
Q: My vehicle is equipped with factory installed anti-theft system. Why do I need XtremeGard® Universal Theft Deterrent?
